Indian Hill Country Club ~ Resident Rules and Regulations ~

Resident Membership

- Newington Residents, 18 years and older, are eligible to play at Indian Hill with a Resident Membership, purchased annually from the Indian Hill Business office.
- All Residents must complete the Membership Application process. Residency must be verified and approved before being permitted to play.
- To join, print the official Application for *Newington Resident Membership* (below).
- Fees must be paid by cash or check. Make checks out to: Indian Hill Country Club
- **MAIL** payment, the Completed and signed Membership Application and proof of residency to:

Indian Hill Country Club @ 111 Golf Street Attention: Resident Membership

- Proof of residency: a photo copy of a license, utility bill, etc. Residency will be verified with the Town of Newington.
- Once the application is approved and processed, your name will be added to the Resident Membership Roster. There will be no more "resident cards".

General Rules:

- Resident access to the golf course runs from April 1st through November 30th.
- Residents are limited to playing **8** times per month.
- Tee Times are not required, except on Monday morning between the times of 8:00am-11:00am. Otherwise, all play is first come, first served.
- IHCC Club Members have tee preference on Mondays from 11am-1pm.
- On Tuesdays, residents and members may have to vacate the course prior to 11:30 A.M. until 5:30 P.M. to allow tournaments hosted by IHCC to proceed (understanding by Newington Town Council 10/01).
- Junior golfer's ages 10 years old to 17 must be accompanied by a parent or guardian when they play. Children under 10 are not allowed on the course.
- Restrooms are located in the main building at the end of the main hall.
- Resident Members do not have access to the Locker Area.
- All of the above are to be considered points of clarification and do not in any way supersede the Town Lease.

Dress Code:

All golfers at Indian Hill are required to follow our posted dress code. Players wearing inappropriate attire will not be allowed to play. Please read carefully:

- *Appropriate attire:* Golf or Flat Heeled shoes, Tucked-In Collared Shirt for Men, Any Golf or Athletic Shirt for Women. All shorts must touch the knee. Pants or Slacks. Hats must always be on facing forward.
- *Inappropriate attire:* Any non-golf cleats or high heels. Denim, cargo pants, cargo shorts, bathing attire, cut offs, gym shorts, short shorts, tee shirts, tank tops, halter tops and mesh shirts.

Rules of Play:

- All residents and their guests must pay their green fee and cart fee inside the Golf Shop <u>before</u> they play.
- All golfers, including Seniors on Mondays, must check in with the Starter prior to beginning their round of golf, without exception. The Starter must verify your name on the Resident Membership list and may ask for identification. In absence of a starter, golfers must check in and show the Membership card at the Golf Shop.
- Residents and their guests may begin play during the stipulated times only. No exceptions are made for seasonal daylight hours.
- Playing 10 holes requires 18-Hole payment of green fees.
- Continuation of a 9-hole round of golf requires check in with the starter and paying for additional green fees BEFORE continuing the round.
- The practice green may only be used during the stipulated "resident times".
- Residents found to be using the golf course without checking in or paying will be asked to leave, be reported to the Dept. of Newington Park & Recreation, and lose golfing privileges at Indian Hill.

Senior Residents:

- Senior Resident qualifies as 62 years of age and older.
- Senior Resident Members pay no green fees on Mondays. However, they must always check in with the Starter or in the Golf Shop. Golf Cart fees are additional.
- Senior Members have priority on the tee from 8:30am to 10:30am on Mondays.
- When playing on Resident days other than Mondays, Seniors must pay green fees.

Guests of Residents:

- Resident Members may bring guests during the available times for resident play. Fees will be equivalent to the Guest Fees of IHCC Members rate.
- Seniors may bring a non-resident *senior guest* on Mondays only at the discount rates applicable to Newington Resident card holders. Bringing guests on any other resident day, ALL guests are charged the regular "Guest of a Resident" fee regardless of their age.
- A guest may only play twice in a month.

Special Restriction:

• Entering the drainage area to the left of the 2nd hole is strictly prohibited. The rocks are loosely placed, and serious injury may result if entering the area. Any resident entering this area will be removed from the golf course and will be reported to the Newington Parks and Recreation Department. Rules of Golf: Play as an environmental lateral water hazard.

Golf Cart Use Waiver and Release of Liability

By tendering your greens fee and/or cart rental fee transaction and operating a golf cart you are opting into the Indian Hill Country Club Golf Cart Waiver & Release of all Claims. You hereby understand and acknowledge the following terms of said agreement:

I understand that it is my sole responsibility to become familiar with the use and operation of the golf cart and agree that I will not attempt to operate the golf cart unless I am completely familiar and comfortable with the operations. I agree to abide by all rules associated with use of the cart and will ensure that my passengers comply with all applicable rules. I further understand and appreciate that upon request, I can request assistance and/or clarification from course staff.

I agree to operate the golf cart in a safe and courteous manner at Indian Hill at all times. I agree to be responsible for any or all damage and replacement costs for the rented golfing equipment. I also agree to the following golf cart rules:

- Golf Cart Operator must be a minimum of 18 years of age and must have a valid Driver's License.
- Golf Carts must be operated properly. Horseplay, racing, or other misuse of cart will not be tolerated. Carts are to be operated on Indian Hill roadways only and not on thru sites or restricted areas. No off road riding.
- Golf Carts must remain within the allotted areas inside Indian Hill.
- Golf Carts can carry a maximum of two people and passengers must be seated at all times when the cart is in motion. Feet/legs, arms, entire bodies must remain inside the cart.
- Report any malfunctions or cart problems to management immediately.
- Remove any trash or personal items.

Anyone found abusing the rules and regulations of the rental golf cart would forfeit all golf cart usage privileges. There will be no refunds made if the cart has to be returned because of operator misuse-

I have no knowledge of any physical impairment that would affect or be affected by the undersigned operating a golf cart at Indian Hill.

I understand that there may be further rules and regulations that must be followed. These rules and regulations may be posted or orally related to the undersigned. I agree to abide by the rules and regulations, and failure to do so may result in my being removed from the premises.

I recognize and acknowledge that there are certain known and unknown risks of physical injury to persons utilizing a golf cart, including but not limited to the following: golf cart rollover, collision with stationary objects, horseplay, negligent driving, being struck by flying objects, and falling out of golf carts. I voluntarily and fully choose to incur any and all such risks and dangers on behalf of myself.

I hereby fully and forever waive, release, and relinquish any and all claims, demands and actions whatsoever that I may have or may accrue to me against Indian Hill, its officers, agents, volunteers and employees arising out or in connection with the use of the golf cart.

I further agree to indemnify and hold harmless and defend Indian Hill from any and all claims and actions resulting from injuries, damages and losses sustained by me or any passenger, and arising out of, connected with, or in any way associated with the use of the golf cart, except to the extent any liability arises out of any willful and wanton act or omission of Indian Hill.
